

## Privacy Notice

The protection of your personal data is of particular concern to us. To ensure that you feel safe when visiting our website, we strictly observe the legal provisions (TSG, GDPR) when processing your personal data and would like to inform you about this at this point. The following privacy policy explains which data is collected from you on our websites and which of this data we process and use in what way and who you can contact if you have any concerns.

### 1 - Who is responsible for this website

This website is operated by SLS Logistics e.U. as the data controller.

which is the **controller** within the meaning of Art. 4 no. 7 GDPR.

If you have any questions about the protection and security of your data or if you wish to assert your rights and claims in connection with data protection, please contact us by phone or e-mail at the contact mentioned above.

When accessing and using **slslogistics.at**, data is collected and used that – as described in more detail below – is personal or may affect your privacy. Without providing your data, you will not be able to use the services offered.

### 2 - What personal data we process

In the course of your visit to our website **cargoe.at**, we will collect the following information:

- The date and time of access to our website
- Your IP address (pseudonymised)
- Name and version of your web browser
- The web page (URL) that you visited before accessing **cargoe.at**

- Certain cookies (see below for more details on cookies)
- And the information that you collect yourself in one of our web forms in the event of a general contact query:
  - Name
  - The Miledresse

We have made sure that we only request the data from you that we need to answer your enquiries.

### 3 – Cookies

Our website uses so-called cookies. These are small text files that are stored on your device with the help of the browser. They do no harm.

We use cookies to make our website user-friendly. Some cookies remain stored on your device until you delete them. They allow us to recognise your browser the next time you visit.

If you do not wish this to happen, you can set up your browser to inform you about the setting of cookies and to allow this only in individual cases.

If cookies are disabled, the functionality of our website may be limited.

If you visit a page on **slslogistics.at** that contains embedded content (e.g. from YouTube), cookies from those websites may also be stored. We do not control third-party cookie settings. We therefore recommend that you obtain information on the use of cookies on the respective website.

### 4 - Web Analytics with WP Statistics

The statistics plugin "WP Statistics" is used on this homepage. This stores local statistical data on page views and visitors. The data is stored within WordPress and can be accessed via the dashboard as lists and graphs. Search engines such as Google, Bing, DuckDuckGo, Yahoo, and Baido are recognized. Search words, referrer, browser and country are saved. Current visitors are displayed on the "Currently online" page. There is a map of the visitor countries, which is determined by GeoIP location.

Your IP address will be recorded, but immediately pseudonymised (replaced by a hash in the database). It is therefore not possible to personally identify a visitor, even retrospectively.

## **5 - Purposes of data processing**

We will only process your personal data for the following purposes:

- To provide you with this website and to develop and improve this website
- To compile usage statistics
- To detect, prevent and analyse attacks on our website
- To be able to respond to your general contact request
- To be able to send you brochures
- To be able to send you relevant offers

## **6 – Legal basis**

The legal basis for the processing of your personal data is our overriding legitimate interest (pursuant to Art. 6 (1) (f) GDPR), which consists of achieving the objectives set out in point 5 - Purposes of data processing above.

## **7 - Transfer of your personal data**

For the purposes set out above (see point 5), we will transfer your personal data to the following recipients:

- IT service providers (processors)
- Logistics service providers (processors)

All processors are contractually obliged by us to treat your data confidentially and to process it only in the context of the provision of services. Some of the above-mentioned recipients are located outside Austria or process your data there. However, we only transfer your data to countries that the EU Commission has decided that they have an adequate level of data protection.

## **8 - Storage period**

Your personal data will only be kept by us for as long as we deem necessary to achieve the purposes of the processing set out in point 5 and as permitted by applicable law. In any case, we store your personal data as long as there are statutory retention obligations or the statute of limitations for potential legal claims has not yet expired.

## **9 - Your rights**

In principle, you have the right to information, correction, deletion, restriction, data portability, revocation and objection. If you believe that the processing of your data violates data protection law or that your data protection rights have been violated in any other way, you can lodge a complaint with the supervisory authority. In Austria, this is the Data Protection Authority.
